#### ADR EXPERIENCE

Proposed and implemented a pilot program staffed by local bar to mediate pro-se small claims disputes in McHenry County and Lake County, Illinois to facilitate quicker disposition of claims for pro-se parties and shorten pro-se trial calendars. Trained all volunteer mediators, drafted proposed rules and forms. This program is now 19 years old and has been the model for Small Claims Mediation Programs which I have helped set up in a number of other jurisdictions. As a result of that experience, have been invited to lecture and meet with Court personnel in Manchester UK, Liverpool UK, London UK, Edinburgh UK, Belfast UK, Milan and Rome Italy.

Was one of the original **mediators** and chaired the committee that drafted the rules in the Court annexed mediation program for the 22<sup>nd</sup> and 19<sup>th</sup> Judicial Circuits. In addition, I am certified in the 17<sup>th</sup> and 21st Circuits (State Court) and on original panel of mediators for the Civil Mediation program in the Federal District Court (Rockford) and the Cook County Circuit Court both for Civil and Chancery cases. To date have mediated more than 2500 court cases.

Have been active **arbitrator** (primarily uninsured/underinsured motorist claims or cases where the parties have agreed voluntarily to arbitrate or are required to do so (as neutral) in more than 600 cases. Have served as a Court Arbitrator in both Lake and McHenry Counties since the inception of those programs.

In 2011 was appointed by the Board of the Illinois Workers Compensation Commission (and served for six years) as one of four "independent" arbitrators statewide to hear worker's compensation claims filed by employees of the Illinois Workers Compensation Commission.

As a founding Board member (President 2007-2014) of the International Academy of Dispute Resolution (See www.inadr.org), a not-for profit organization which trains mediators and conducts mediation tournaments for students world-wide, I have participated in conducting training and competition at more than 75 tournaments in Chicago, Boston, Des Moines, London, Dublin, Liverpool, Oxford, Glasgow, Bhopal, India and Dubai, UAE.

Co-instructor of 40 hour training course for mediators outside the USA with the head of International Training for ADRg, one of the UK's largest ADR providers. We provide a "co-badge" certificate recognized in the UK and most jurisdictions in the US requiring a 40 hour training program.
